### **Behaviour Management and Discipline Policy**

Following the reintegration and return of all children from 1<sup>st</sup> September 2020 the following extra measures linked to behaviour management and discipline will be in place:-

### Scope

This addendum applies until further notice.

It sets out changes and exceptions to our normal behaviour policy. Children, parents and staff should continue to follow our normal behaviour policy with respect to anything not covered in this addendum.

We may need to amend or add to this addendum as circumstances or official guidance changes. We will communicate any changes to staff, parents and children.

# Expectations for pupils in school New rules

When children are in school, we expect them to follow all of the rules set out below to keep themselves and the rest of the school community safe.

Staff will be familiar with these rules and make sure they are followed consistently.

Parents should also read the rules and ensure that their children follow the new procedures that have been put in place. Parents should contact Miss Bridges (Headteacher) if they think their child might not be able to comply with some or all of the rules, so we can consider alternative arrangements with them and support them to integrate back into school life.

### In the Classroom/Outside

When the children return to school time will be spent agreeing and establishing the following rules:-

- ✓ Keep at least 2m away from other Bubbles of children/adults at all times
- ✓ Try to limit the close contact you have with other children and adults within your Bubble although we know that's not always going to be possible and that is okay as long as it's just within your Bubble
- ✓ When lining up ready to come into school stand on a painted spot where your teacher asks you to stand.
- ✓ When queueing in school stand on the circular numbers where your teacher asks you to.

- ✓ When using the sinks in the toilet block only use those where there are no signs saying 'DO NOT USE'.
- ✓ Follow the one-way system when in the toilet block
- ✓ Keep your hands away from your face, mouth and eyes
- ✓ Keep your own equipment in your trays on your table only use your equipment or other equipment/resources/toys that your teachers give you.
- ✓ Only play with your own Bubble's box of toys during playtimes and dinner time playtimes
- ✓ Follow the cleaning and hygiene rules that your teachers set you particularly washing your hands regularly and using hand sanitiser regularly.
- Follow the Catch it Bin it Kill it rule when coughing and sneezing then wash your hands thoroughly - do not cough or spit at or towards any other person
- ✓ At playtimes only play in the areas of the school where your teachers tell you to
- ✓ Tell an adult if you are experiencing symptoms of coronavirus

### Rewards and sanctions for following rules

We maintain all of our usual rewards when children choose to follow the rules including verbal praise, house points and weekly Effort cups.

However, if children choose not to follow these rules, we have a hierarchy of sanctions/consequences for inappropriate behaviour all the children are aware of these. For all classes the following consequences will be used:-

### Verbal warning

• Step 1: Name on board This serves as an initial warning (teacher does this)

If there is no change, another verbal warning.

• **Step 2:** One tick 5 minutes playtime lost standing by their Bubble adult (teacher does this)

If there is no change, another verbal warning.

 Step 3:Two ticks

 standing by their Bubble adult (teacher does this)
 1 complete playtime lost (No longer than 15 minutes)

If there is no change, another verbal warning.

• **Step 4:** If children keep failing to follow the rules Miss Bridges is informed, Miss Bridges contacts parents who are asked to come and collect their child from school as they are putting the health and safety of all at risk by failing to comply with the rules.

### Monitoring arrangements

We will review this policy as guidance from the local authority or Department for Education is updated, and as a minimum termly by Miss Bridges (Headteacher) At every review, it will be approved by the full governing board.
